Philadelphia Fdn Grant- (\$10K) not received, Wells Fargo grant- 5th payment received (one payment left, \$24k/year will no longer be apart of revenue stream, Eagle workers fund (from fmr community living property)- was \$14k less than before (may indicate a downward trend).

#### **Executive Director's Report:**

  - 9/26- Mt. Airy BID has invited the Board to a dedication ceremony celebrating the completion of five pocket parks and the generous sponsors -- including EMAN! Will be held at the Trolley Car Park 5:30 - 7:00 p.m. Will also include revealing new signage.

#### Last Event Recap

#### **Upcoming Events**

Chew on the Ave (9/21) has been postponed until further notice:

- Events application was approved by the City but denied by the 14th police district stating there were "issues" in that location which would require a larger police presence.
  - EMAN will follow up with the Captain of the 14th District to learn more about the "issues" and learn what how we can work together to improve the issues.
  - We will also engage with neighbors of the Southside/Bottom so they have a voice in this process as well
  - Board members also offered viable location alternatives (I.e., Pleasant Playground or Wissahickon Charter School)
  - WE ARE NOT GIVING UP!

#### Toast of Mt. Airy (11/9)

- Will be provided more budget/logistical/ticketing information following the Special Events Committee mtg (9/26)
- Will create marketing materials for sponsorship packages.
- To curtail acceptance speeches, wlll explore possibly creating videos of organization information for grantee recipients during this time.
- Will look into possible discount/promotion codes through our payment system.
- Chair implored board members to please support EMAN special events however they can. "Stewardshiptime, talent and treasure".

**Zoning:** Committee proposed revisiting discussion around Zoning Committee having an independent vote as an alternative if the community consensus is to vote against a project that the committee believes is a sound and satisfied it meets zoning requirements conducive to the neighborhood.

- There was heated dialogue surrounding this proposal highlighting concerns what precedence this separate vote will set, especially if the vote goes against the neighbors.
- Overall, members feel we should explore educating the neighbors more about the zoning process (especially the timeline leading to zoning hearing) to mitigate discrepancies between community consensus and zoning committee recommendation that produces an informed, uniform, vote.
- Motion to "table the discussion until the next meeting" granted.
  - o In the interim, Patrick will meet with Zoning committee to further workshop the proposal.
  - Will also ask Christian, from Councilwoman Bass office, to come to a future Board meeting for an overview of the zoning process.

#### **New Business**

- There has been a complaints by neighbors that live near Emlen Elementary school regarding Beer deliveries occurring during the time of school dismissal.
  - Proposed to have Councilwoman Bass to issue a citation to the business owner that should deter future deliveries due to ramifications that involve license being revoked if issue not rectified.

### **Committee Reports**

#### **Communications and Development Committee**

The Committee met briefly on Saturday, September 21<sup>st</sup> to discuss goals and projects for the Committee and EMAN. We agreed that there are short-term and long-term projects we should be pursuing.

First, short-term, we believe that we could use social media to build out the "Resources" tab of the website. EMAN can post asking organizations to email us with their program description and who is eligible would help generate a good list of resources for neighbors. We would likely use standard hashtags (#EMAN, #EMANResources, #PHL) to ensure it was accessible. Once we have more programs in our bank, we could then do a weekly post to highlight a partner in the neighborhood.

Second, long-term, we would like to take some time to evaluate EMAN's overall social media presence to develop better, targeted content. This would entail looking at our social media metrics (who is our audience, when do they interact with us, what are their interests). Additionally, this would include asking neighbors about how they identify EMAN and what they would like to see on our social media channels.
